CONDITIONS


1. The landowner assumes responsibility for compliance with the Virginia State Seed Tree Law.
2. A period of time of **24 months** will be allowed to cut and remove the timber.
3. **Driveway:** Along the driveway within 30' on each side are red flagged trees that are to be retained and not harvested.
4. **Access and Field Edges:** A 30' path along the field edges will be allowed to access the harvest area.
5. **Harvest Area:** Sawtimber trees within the Clear Cut areas are marked with BLUE PAINT and within the Selective Harvest and SMZ's the trees to be harvested are marked with YELLOW PAINT.
6. The main road that bi-sects the property **must** be maintained during logging in at least a passable condition as is at present and shall be restored to its original condition upon completion of the logging. Any newly constructed roads and decks must be left in a graded condition and must be seeded upon completion of logging. Any newly constructed haul roads, skid roads and log decks and all logging operations must be in accordance with the guidelines set out in the **Best Management Practices Manual** of the Virginia Department of Forestry.
7. No tops or laps will be allowed to remain in the streams, fields, buffers or over cutting boundaries. They must be pulled back immediately.
8. Only the **YELLOW** marked trees are to be cut from the Streamside Management Zones and from the Selective Harvest area.
9. No logging will be permitted during excessively wet weather conditions as determined by Timber Marketing & Management, Inc. If logging is halted due to weather conditions, then an extension of time equal to the time lost will be granted.
10. A **\$3,500.00** performance bond will be paid at closing and held by Timber Marketing & Management, Inc. to insure compliance with all BMP requirements, road maintenance and conditions of the Timber Purchase Contract.

Only sealed bids will be accepted and owners reserve the right to reject any or all bids.
